- + Florida House Bill Intro Deadline: Exceptions: appropriations bills, appropriations implementing bills, appropriations conforming bills, local bills, Senate resolutions, concurrent resolutions pertaining to a legislative joint session, a session extension, joint rules, procedure, organization, recalling a bill from the Governor, or setting an effective date for a bill passed over the Governor's veto, committee bills, trust fund bills, and public-record exemptions that are linked to timely filed general bills.
- + Florida Senate Bill Intro Deadline: Exceptions: appropriations bills, appropriations implementing bills, appropriations conforming bills, local bills, Senate resolutions, concurrent resolutions pertaining to a legislative joint session, a session extension, joint rules, procedure, organization, recalling a bill from the Governor, or setting an effective date for a bill passed over the Governor's veto, committee bills, trust fund bills, and public-record exemptions that are linked to timely filed general bills.
- + Florida Crossover Deadline: The House may only consider returning messages, conference reports, and concurrent resolutions. Additionally on April 28, 2019, the House may no longer consider House bills that are on second reading.
- + North Carolina House Bill Intro Deadline: This is the deadline for bills required to be considered by the Finance or Appropriations Committee. Bills not required to be considered by Finance or Appropriations must be introduced by April 9, 2019. Local bills and bills submitted for a department or agency must be introduced by March 20, 2019. Bills submitted for a commission or standing committee must be introduced by March 6, 2019.
- + North Carolina Senate Bill Intro Deadline: (Local bills must be introduced by March 6. Two-thirds majority vote is required to introduce bills after this date.)
- + North Carolina Crossover Deadline: Does not apply to bills that must be referred to Finance or Appropriations Committees, bills establishing state or local districts, or adjournment resolutions.
